1. Any exhibitor under the age of 19 and still in high school will be allowed to enter the show. Pre-club exhibitors must be able to exhibit his/her hog without the assistance of an adult or older exhibitor in the ring.
2. Entries will be limited to the **first 200 head of swine entered**. Once this number is reached, we will stop accepting entries for the show. If the entries have already been mailed, we will notify the exhibitor and return their entry to them.
3. Exhibitors who are housing pigs in the barn will be given a pen assignment. The pens are 5' X 5' and only 16 will be available. The pens are assigned on a **first-come, first-served basis** as PAID entry forms are received. There will be one pig per pen. The pens will have shavings however if you would like to freshen your shavings please plan on bringing your own. No tack pens will be provided. Exhibitors may show off the trailer.
4. Registration papers for all registered hogs must be present at time of check in.
5. There will be a purebred division for the following breeds: Berkshire, Duroc, Hampshire, Yorkshire and AOB.
6. All entries must be accompanied by current health papers at the time of check-in.
7. All market hogs must be tagged, and tag numbers must be included on the entry form. **Absolutely no hogs will be accepted without an ear tag.**
8. Check-In will take place from **7:00 – 9:00 AM** on Saturday January 3rd. The **show will begin at 10:00 AM**, or as soon as weight classes have been broken.
9. Showmanship will be broken into grade ranges after the entries have been received.
10. Show management reserves the right to change, combine or delete classes with insufficient entries.
11. After pigs have been weighed and leave the scales, there will be no changes made. Any changes that need to be made must be made before leaving check-in.
12. Payout will be determined upon the number of entries.
13. The judge's decision is final in all classes.
14. Exhibitors are responsible for his or her own animal and must assume all associated risk.
15. Crawford County BOE, Crawford County High School and Crawford County Farm Bureau, nor anyone or anybody associated with the Crawford County Young Farmer Swine Show are liable for accidents, injuries, or theft.
