

Livestock - General Information

<u>Exhibitor's Pass</u> - Each exhibitor will receive four Exhibitor Passes upon arrival at Livestock Check-in. Livestock Parking will be available for trailers only and all other vehicles will be in general parking.

Health Regulations - (Requirement for the Exhibition of Livestock in Georgia)

All animals being exhibited in any type of livestock show (local, county, area, district, or state) must have an official certificate of veterinary inspection (health certificate). This certificate of veterinary inspection must be issued within 30 days of the exhibition - except for 4-H and FFA shows. See the current year Georgia 4-H and FFA State Livestock Shows Rules and Regulations for specific information for 4-H and FFA health certificates. All other livestock exhibitors must follow rules and regulations as outlined in the "Health Requirement for Exhibition of Livestock in Georgia," revised October 7, 2003, by the Georgia Department of Agriculture. No animals will be allowed entry onto the fairgrounds without the proper health records and test requirements.

General Rules - Applicable to all Livestock

All entries shall be classified immediately upon arrival and classification cannot be changed.

All livestock and poultry must conform to Health Regulations as outlined above.

All livestock may be subject to health inspection by an Official State Veterinarian.

The livestock barn will be open during all fair hours from August 21st - 24th, 2025.

Livestock receiving hours are <u>before</u> fair operating hours. Vehicles will be allowed to pull up to the barn, unload promptly, and drive to the designated parking area. Please refer to each species for receiving dates and hours. Livestock may be removed following the show. Vehicles will be permitted on the fairgrounds in the designated loading/parking areas and for designated times only.

Outside food may only be brought onto the fairgrounds before operating fair hours.

The contestants must be present at the time of judging or make prior arrangements to have their animals shown due to a legitimate excuse.

Premium awards will be awarded for places first - fifth in weight classes and showmanship classes. First-\$25 Second- \$20 Third- \$15 Fourth- \$10 Fifth- \$5 Grand and Reserve Payouts are \$75 for Grand Champion and \$50 for Reserve Grand Champion. Ribbons will be given for placings 1-8. Division Champions will be awarded (beef) First- \$25 Second- \$15. All premiums will be paid by the Treasurer of the Chattooga County Agricultural Fair.

The fair council reserves the right to cap the show based on available space.

All livestock must have a creditable showing to qualify to receive a premium.

Premiums will not be awarded without entry fees paid.

There will be a \$35 processing fee on all returned checks.

Where there is no competition in a class and champion showing, either second prize or reserve champion money may be given.

Each exhibitor must furnish their feed, feed pan, water pail, and show supplies. The fair will furnish the bedding, electric power, and water supply. It is the responsibility of each exhibitor to feed, water, clean up after their animals, and provide general care for their animals while at the fair.

Veterinarian service for all animals, while at the fair, will be made available at the owner's expense.

The fair will not be responsible for loss or damage to any exhibit and will give the best care and attention to prevent loss or damage.

There will be showmanship classes. Classes will be determined by grade level.

An exhibition "fun class" for pee wee showmen will occur before the weight classes. There is no entry fee, and only ribbon placings will be awarded. Very young children may need to be accompanied into the ring.

We shall honor the Statement of Relation (Memorandum of Understanding) between Vocational Education and the Cooperative Extension which is considered the official agreement. This agreement guides 4-H and FFA participation in events. The agreement intends to support youth participating in both organizations with different project areas and to disallow a young person from competing in both organizations with the same project area in the same year.

Application for all livestock entries shall be in the hands of the proper livestock department representative no later than Friday, August 13th, 2025.

Market Goat, Market Lamb, Beef, and Dairy entry is a non-refundable fee of \$15 per animal with a maximum of three entries per species. Showmanship is included in this fee. There will be a \$15 late fee to any animals added after the registration date. **No phone or Email entries are accepted.**

Chattooga County Livestock Committee reserves the right to cap the show if the committee sees fit.

Junior Beef Show Rules and Regulations Chattooga County Agricultural Fair August 23rd, 2025 1:00 pm

1. The show is eligible to all Georgia 4-H and FFA members. Cherokee and DeKalb Counties of Alabama are also eligible. If the show does not meet maximum capacity considerations outside of the eligible counties will be taken upon request. Fair Council reserves the right to cap the show based on available space.

2. Cattle must have an official state ear tag or other identifying ear tag and must match the entry form identification number. All steers and commercial heifers must have their (state) ear tags. If a steer or commercial heifer is entered that will not be entered for the GA 4-H & FFA state show in Perry in February, the animal STILL must have an ear tag for identification purposes for the conducting of the show.

3. For the entry to be complete, an entry form signed by the parent, agent/teacher, and the exhibitor must be mailed with the correct entry fees by August 13th, 2025. Entry fees are \$15.00 for each animal, with a maximum of three animal entries. There will be an additional \$15 late fee for each entry added after August 13th. NO EMAIL SUBMISSION ACCEPTED

4. Beef entries will check in upon arrival and tie-outs are pre-assigned. Check-in will be from 8:00 am to 10:00 am on August 23, 2025. The show will begin at 1:00 pm.

5. Following the Rules and Regulations according to the 2025 Georgia State Show birth dates are as follows:

Steers: Calves are suggested to be born after August 1, 2024

Heifers: Heifer Calves will be born after January 1, 2023

6. All returned checks will be subject to a \$35 processing fee.

7. Original registration papers must be in the name of the official exhibitor of this animal only for all registered heifers and submitted at the time of weigh-in.

8. Registered heifers without original registration papers WILL NOT be moved to a commercial class and vice versa thus making that animal not eligible to be shown. The entry fee will not be refunded.

9. Heifers will be shown in 2 divisions, by Registered and Commercial status. Steers and commercial heifers will be shown by weight and registered heifers by age. First and second-place division winners will be placed to compete for Grand Champion and Reserve Grand Champion.

10. All beef entries must be dehorned. Any regrowth should be rasped and presentable for the show.

11. Showmanship classes will be based on grades in school.

12. An exhibitor will not be permitted to enter the show ring with another student's entry unless the animal belongs to an exhibitor with two entries in the same class.

Junior Commercial Dairy Heifer Show Rules and Regulations Chattooga County Agricultural Fair August 24th, 2025 1:00 pm

1. Show is eligible to official 4-H and FFA members from all Georgia counties. Cherokee and De Kalb Counties of Alabama are also eligible. If the show does not meet maximum capacity, considerations outside of the eligible counties will be taken upon request. Fair Council reserves the right to cap the show based on available space.

2. All heifers must be in possession of the exhibitor on or before August 1, 2025.

3. Heifers must be ear tagged with an official state ear tag or other identifying ear tag and must match the entry form identification number. Tattoos are required on solid-colored calves only; however, they are highly recommended on all calves. The tattoo number need not correspond to the ear tag number.

4. An entry form signed by the parent, agent/teacher, and the exhibitor must be mailed with the correct entry fees by August 13th, 2025 for the entry to be complete. Entry fees are \$15.00 per animal, with a maximum of three entries per showman. Showmanship is included with the entry fee. **There will be an additional \$15 late fee for each entry added after August 13th**. <u>NO EMAIL SUBMISSION ACCEPTED</u>

5. All returned checks will be subject to a \$35 processing fee.

6. Heifers will check in upon arrival. Check-in will be from 8:00 am - 10:00 am on Sunday, August 24^{th} , 2025. The barn will be open at 8:00 am for receiving. The show will begin at 1:00 pm.

7. Heifers shall meet the following requirements to be eligible:

- A. Heifers must be born between March 1, 2024, and August 1, 2025.
- B. Commercial dairy heifers may be of mixed breed or any dairy breed.
- C. All heifers must be dehorned. Heifers not dehorned will be disqualified.
- D. Heifers must meet the minimum weight of 100 pounds or will be sorted from the show.

8. Heifers will be sorted into classes by weight.

9. Showmanship classes will be based on grades in school.

10. An exhibitor will not be permitted to enter the show ring with another student's entry unless the animal belongs to an exhibitor with two entries in the same class.

1. Show is eligible to official Georgia 4-H and FFA members statewide. Cherokee and DeKalb Counties of Alabama are also eligible. If the show does not meet maximum capacity, considerations outside of the eligible counties will be taken upon request. Fair Council reserves the right to cap the show based on available space.

2. Goats must have an official state ear tag or other identifying ear tag and must match the entry form identification number.

3. An entry form signed by the parent, agent/teacher, and the exhibitor must be mailed with the correct entry fees by August 13th, 2025 for the entry to be complete. Entry is a non-refundable fee of \$15 per animal with a maximum of three entries per species. Showmanship is included in this fee. There will be an additional \$15 late fee for each entry added after August 13th. <u>NO EMAIL SUBMISSIONS ACCEPTED</u>

7. Goats must have their milk teeth. Goats showing either or both of the first pair of permanent incisors will not be able to show.

8. All goats must be dehorned or have horns tipped.

9. Goats will be weighed and divided into classes. There will be a market wether show and a market doe show. Goats must meet a minimum of 20lbs. Goats not making minimum weight will be sifted from the show and returned to the exhibitor. No entry fee refund will be given for goats that are sifted from the show.

10. Showmanship classes will be based on grade in school.

11. An exhibitor will not be permitted to enter the show ring with another student's goat unless the goat belongs to an exhibitor with two entries in the same class.

2. Lambs must have an official scrapies ear tag and must match the entry form identification number.

3. An entry form signed by the parent, agent/teacher, and the exhibitor must be mailed with the correct entry fees by August 13th, 2025 for the entry to be complete entry is a non-refundable fee of \$15 per animal entered with a maximum of three entries per species.
