Rules and Regulations:

- 1. All Georgia 4-H and FFA State Livestock Rules and Regulations will be followed.
- 2. Animals will be weighed and divided into classes as evenly as possible. After they leave the scales there will be no re-weighs.
- 3. Classes: Exhibitors must show their own animal in class. If the exhibitor has more than one animal in a class, they can have another exhibitor show for them. This must be cleared with show officials before showing.
- 4. Showmanship: Each exhibitor must show their own animal in showmanship. The animal must be entered in the show and owned by the exhibitor.
- 5. All does must be dehorned or have horns tipped.
- 6. All animals must be ear tagged with state identification tags.
- 7. The entry per animal is \$25. The entry for showmanship is \$10 per showman and will be classed by grades. Entry deadline is January 20, 2023. NO LATE ENTRIES!
- 8. Pens will be assigned and are \$8 each (includes shavings); no extra pens will be available the day of the show. We will have paid trailer parking around the building, \$25 per spot. If showing off trailer it is your responsibility to be in the show ring on time. Trailer Parking is limited and must be reserved prior to the show. Trailers will be parked in the order of which they arrive. Please contact Bryan Christian 706-246-5630 to reserve a spot.
- 9. A certificate of Veterinary Inspection is required with the individual identification and the following statement: Flock of origin is free from Foot Rot, Scabies, Contagious Ecthyma (sore mouth), Cutaneous Fungal Lesions, Scrapie or any other Infectious disease. All Does must have a USDA approved scrapie tag in the ear. Registration numbers will not serve as the scrapie tag for the show.
- 10. Weigh in will be 6:30 AM 8:00 AM. Show starts at 9:00 AM. Barn will open at 6:00 AM Saturday. Set-up is allowed on Friday 5:00 PM 8:00 PM (MUST be out by 8:00 PM, BARN WILL BE LOCKED).
- 11. The Jackson County Agricultural Facility accepts no responsibility nor assumes any risk for injury to the exhibitor or animal due to or resulting from participation in the Premier Miss Show.
